The form is required for grant applications submitted to government agencies. After the research plan is approved, the genetic recombination experiment must be carried out consistent with the application. If the experiment is changed to a higher biosafety level, the PI is required to fill out and submit the "application form" again to the Biological Safety Commission for approval.

II. Purpose of Personal Data Collection
